# **VAC-U-G©** Sampling Pump Catalog No. 228-9605 (120V, 60 Hz) 228-9605B (240V, 50 Hz)

The VAC-U-GO non-compensating vacuum pump is a rotary vane-type pump that provides flows up to 30 L/min and maintains sonic flow when used with a critical orifice. AC-powered and portable, the VAC-U-GO Sampling Pump can be used for a variety of ambient and indoor air sampling applications including asbestos, bioaerosol, stack, VOC, and fenceline monitoring. It is ideal for sampling bioaerosols using the SKC BioSampler or the AGI-30 Impinger.

The line-operated VAC-U-GO Sampling pump has a permanently lubricated motor that is mounted in a housing with a vacuum pressure gauge to indicate sonic flow and a throttling valve to adjust flow. Both models are supplied with an extension rod for mounting media and a power cord. Critical orifices in flow rates ranging from 2 to 12 L/min are available as accessories. No critical orifice is needed if using the VAC-U-GO Sampler with the SKC BioSampler.







## \*VAC-U-GO Sampler Notes

#### A. About Sonic Flow

Sonic flow is attained when a vacuum pump pulls air through an orifice to create a condition where the downstream pressure is 52% of the upstream pressure. At this point, air velocity through the orifice has reached the speed of sound and cannot increase, therefore, the orifice becomes "critical." The fixed air velocity at the critical orifice also limits the airflow so that the condition remains constant regardless of pressure variations in the system. Airflow will remain constant at vacuum levels between 15-30 inches Hg.

#### B. Sampling with the SKC BioSampler

The BioSampler has built-in critical orifices so no other orifice is needed.

### C. Sampler Limitations

This vacuum (rotary vane-type) sampler is non-compensating and, therefore, unsuitable for compliance sampling in non-sonic mode. Sonic mode yields a more constant flow when back pressure across the media increases.

Vacuum (rotary vane-type) pumps produce a high-pitched whine when running. For low noise, compliance (non-sonic flow) applications such as indoor air studies, use a compensating high-volume AirChek® HV30 (Cat. No. 228-030), or Hi-Lite 30 (Cat. No. 228-031) pump.
